Response to New Displacements

Darfur

North DARFUR

► Background

Clashes between armed groups in the Shaeria area cause displacement of populations to Dar El Salam camp on 27 July. Insecurity in Ozban displaced households to Zam Zam Camp.

Tribal fighting in Jebel Mara displaced households to Kabkabiya.

Ongoing fighting in East Jebel Mara led to displaced persons to Shangil Tobayi.

Insecurity due to fighting in the Tawila area has resulted in displacement of about 300 HHs.

► Background

Heavy fighting has taken place in the East Jebel Mara (EJM) area since early February and is ongoing. The Humanitarian Country Team and UNAMID are monitoring the situation and working to gain access for agencies to assess the humanitarian situation.

Inter-tribal fighting in displaced households to Nyala locality.

Displacements to areas in the Kass locality were reported.

Populations from Northern Bari Payam formerly displaced to Kapuri, Rambur Luri, Kabo, and Gurei started returning home after improvement in the security situation.

Displacements were reported to Liwolo Payam due to conflict on the border of Uganda and South Sudan.

JONGLEI

► Background

Report on forced displacement of Lou Nuer received from Nassir County Authority. 5,200 people have arrived in Akobo County.

Due to political and ethnic tensions as well as ongoing disarmament process, there is widespread tension. Renewed clashes resulted in displacing people in Fashoda. Humanitarian agencies are unable to access to the area. NFI distributions have been completed in Lul and Fashoda.

Households in Duk Payuel were reported to have been affected by the floods caused by heavy rains.

Heavy rains in Aweil town caused flooding in town centre displaced households to two nearby camps.

UNITY STATE

► **Background**

Cross border inter-tribal fighting between Unity and Warrab States in January and February displaced populations to Panyijar, Unity.

Seasonal flood in Leer caused displacement in three payams (Kaigai, Thornyor, and Pilieny) in Leer County. SSRRC and I/NGOs organized assessment to verify humanitarian needs.
